More than 20 residents from Clackamas County are volunteering their time, energy and expertise as members of the TSP's Public Advisory Committee (PAC). So far the PAC has developed a vision, goals and objectives for the update project (which were approved by the Board of County Commissioners in April), and developed and approved evaluation measures for potential transportation projects. PAC subgroups are working with community members to identify transportation needs in five specific areas of unincorporated Clackamas County – Clackamas Regional Center/Industrial, McLoughlin, Northwest, Southwest and East. We are looking for your feedback on the potential transportation projects throughout unincorporated Clackamas County. Share your questions, concerns or comments about these projects. Which do you think are a priority and which do you think should be removed from the County's Transportation System Plan?

A few findings from our work so far:

- A need for projects throughout the County that improve safety for all roadway users including pedestrians and cyclists.
- In rural areas, facilities for pedestrians and cyclists (even roadway shoulders) are very limited.
- In urban areas, the basic pedestrian and bicycle networks have significant missing pieces.
- The urban areas of the County will have significantly more congestion in the future than today.
- Building additional roadways and widening existing roadways can not eliminate all congestion.
- Investment in transit, walking, and cycling facilities is critical to growth and jobs in the urban area.

VISION – Building on the foundation of our existing assets, we envision a well-maintained and designed transportation system that provides safety, flexibility, mobility, accessibility and connectivity for people, goods and services; is tailored to our diverse geographies; and supports future needs and land use plans.

Goal 1: Sustainable

Provide a transportation system that optimizes benefits to the environment, the economy and the community.

Goal 2: Local Businesses and Jobs

Plan the transportation system to create a prosperous and adaptable economy, and further the economic well-being of businesses and residents of the county.

Goal 3: Livable and Local

Tailor transportation solutions to suit the diversity of local communities.

Goal 4: Safety and Health

Promote a transportation system that maintains or improves our safety, health, and security.

Goal 5: Equity

Provide an equitable transportation system.

Goal 6: Fiscally Responsible

Promote a fiscally responsible approach to protect and improve the existing transportation system, and implement a cost-effective system to meet future needs.

Div's Goals & Objectives

TSP Update Based on Current Conditions and Future Needs

Our next steps include re-evaluating all of the County's currently planned transportation projects, and evaluating the new projects, ideas and approaches identified by the public addressing our transportation needs. Then we will start identifying our priorities for the next 5, 10, and 20 years.

In order to identify what transportation projects are needed for the next 20 years, we first need to know what we have now, how well it's working, what our goals are for the future and, then, what projects (construction and maintenance) would meet the needs of the community in the future. We recently concluded a review of the current transportation system, including existing conditions for drivers, freight, pedestrian, bicyclists and transit riders.

We also analyzed two scenarios for future transportation conditions – one with building projects that have available funding and the other showing what conditions would be like if all planned projects, regardless of whether funding is available, were built. During the next few months, with the leadership of the Public Advisory Committee and input from the community we will analyze projects that are currently planned and consider other projects suggested by the PAC and the public. A lot of work will be done to evaluate possible projects, eliminate those that are not needed, add any new ones and then set priorities.

Where We're Headed

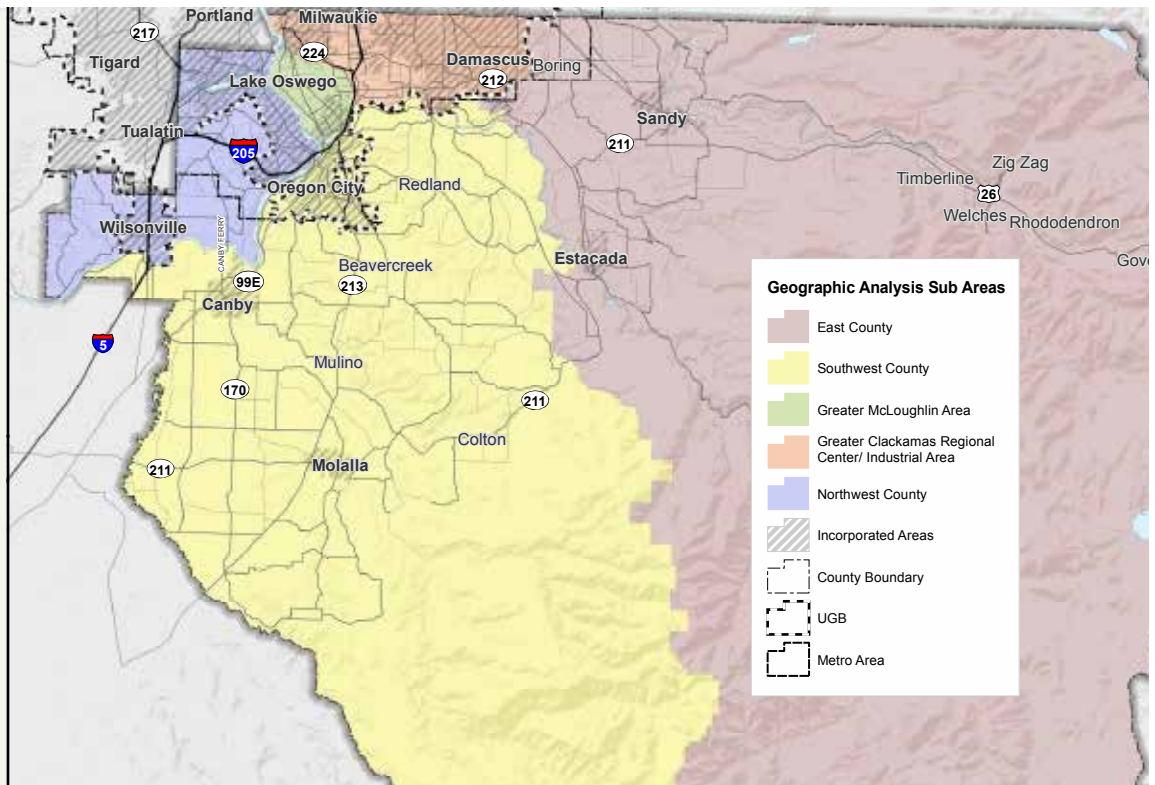

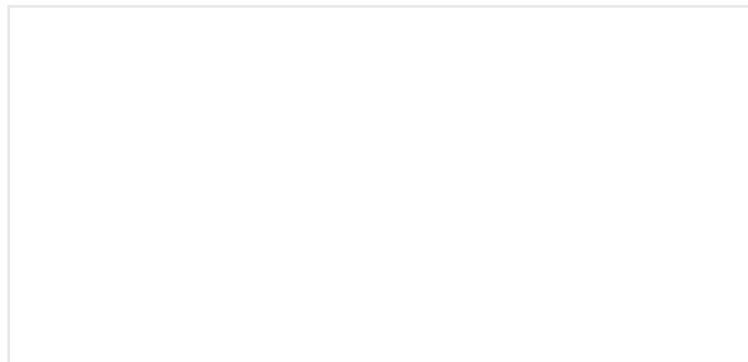
