

- 1. Project Overview- Marc and Ashleigh provided an overview of the TSP process and an explanation for the importance of a TSP.
  - a. Project Purpose- TSP is a means to regulate future growth and development, help strengthen Crook County grant proposals for funding, and maintain consistency with state requirements.

## b. Study Areas:



- c. Project Schedule
  - i. Draft TSP to be completed next June
  - ii. Adoption next summer
  - iii. Open house after next TAC/PAC meeting in February
  - iv. Traffic counts were performed 1-2 weeks before Thanksgiving
- d. Roles & Responsibilities
- 2. Plans & Policy Review (Tech Memo #1)- Darci explained that the purpose of Tech Memo 1 is to review requirements, policy, and relevant guidance pertaining to TSPs and to ensure that the TSP is maintaining consistency with all necessary documents.
  - a. Highlights:
    - i. Transportation Planning Rule (TRP) directs local TSPs to integrate land use planning with the transportation system
    - ii. TSP will be adopted as a chapter of the Comprehensive Plan
    - iii. TSP will help prioritize projects for funding
    - iv. Project Management Team (PMT) will upload links to the documents reviewed by the Plans and Policy review to the TSP project website

- 3. Draft TSP Goals & Objectives (Tech Memo #2)- Ashleigh explained the goals and objectives included in the Draft Tech Memo 2 and led a discussion about changes or additions that need to be made. The major points from the discussion are as follows:
  - a. Topics may be included under more than one goal, if applicable
  - b. Pay attention to the following words, as they suggest different amounts of weight placed on each item:
    - i. "Consider, Support, Encourage, Promote, Prioritize"
  - c. KAI to add transit service as one of the objectives in section 1
  - d. KAI to add ADA compliance as an objective
  - e. Include access to Juniper Canyon in objective 1.2 (may also be included in Goal 3)
    - i. 1/3 of the population lives in Juniper Canyon but there is only one road for access
    - ii. May be safety hazard
  - f. Add "promote access" to recreational areas, including Ochoco National Forest, reservoirs, and trail systems
  - g. Provide more access to higher education opportunities throughout the region-include in connectivity or economic development goals
    - i. Connect to Redmond, Prineville, & Bend's campuses
  - h. Increase connectivity to jobs outside of county
  - Movement of farm equipment- include in safety and/or economic development sections
  - j. Safety- traffic calming
    - i. Can change the look and feel of roads without actually narrowing them, in rural areas especially
    - ii. May be included in subdivision codes for future developments
    - iii. Do not want to narrow access too much so that it constrains access by emergency vehicles
  - k. Need to include pedestrian crossings as an objective, where applicable
  - I. Continue to "promote" multimodal/active transportation
  - m. Look for ability to include park and rides as an objective
  - n. Add objective for linking health, environment, and transportation for active transportation
- 4. Discussion/Identification of Key Transportation Issues- *Each person at the table shared key transportation topics that they identify need to be addressed. Those topics are as follows:*

- a. The regional nature of the County provides unique challenges
  - i. How can we make our trips more efficient?
  - ii. Can we make 126 a safer corridor and have fewer trips?
- b. Improving active transportation and the community's health
- c. Creating data moving forward- keeping the County's database up to date
- d. Providing safe access for pedestrians and bicycles
- e. Improving safety along Juniper Canyon road for motor vehicles and bicycles
- f. Ability to incorporate new, large employers to key industrial areas
- g. Improving access to transit for economic development
- h. Improving access for emergency services and improving address data
- i. Winning funding for transportation
  - i. Currently funding is very limited
- j. Improving the transition from rural/county roads into city streets for annexation
- k. Addressing current and future traffic in industrial areas (Tom McCall Road)
- I. Improving access/safety on Juniper Canyon, especially with steep grade combined with snow/ice
  - i. Currently many accidents
- m. Maintaining infrastructure-
  - i. 111 bridges, only 42 of which are eligible for common state and federal funding
  - ii. All aging and need to be replaced
- n. Easing rural routes that have traditionally had little to no traffic
- Access to recreation- many cars are starting to use the few alternative routes that are possible, but these routes are where the most bicycles and pedestrians are located
- p. Improved signage for major destinations
- q. Emergency preparedness, especially in very rural areas
  - i. Eclipse will bring many people into rural areas next year
- r. Promoting alternative modes of transportation
- Maximizing economic benefits of the airport and freight depot, which have great potential
- t. Supporting oversized loads
  - i. Many travel Washington to Arizona

- ii. Railroad trestle diverts oversized loads onto unsubstantial roads
- u. Secondary access to the airport
- v. Connections with Redmond airport
