 - 1.1.2 Providing public transit and connections to public transit.
 - 1.1.3 Encouraging the reduction of car trips through carpooling, vanpooling, rideshare, transportation demand management, , transit pass programs, and telecommuting.
 - 1.1.4 Encouraging the use of alternative-fuel vehicles.
 - Objective 1.2: Reduce transportation-related greenhouse gas emissions to targeted levels.
 - Objective 1.3: Minimize the air and water quality impacts of transportationrelated activities.

- Customize transportation solutions to suit the local community.
- > Objectives
 - Objective 3.1: Expand transportation choices for all users.
 - Objective 3.2: Facilitate access to daily needs and services
 - Objective 3.3: Create successful and enduring communities
 - Objective 3.4: Create a resilient transportation system that can adapt to evolving land use and fit the desired future, while meeting present needs.
 - Objective 3.5: Further access to recreational opportunities and public lands.



Goal 4: Health and Safety

- Promote a transportation system that maintains and improves individual and community health, safety, and security.
- Objectives
 - Objective 4.1: Provide for and encourage use of safe, non-motorized transportation options to support public health.
 - Objective 4.2: Optimize the transportation system's ability to facilitate emergency response services.
 - Objective 4.3: Ensure that the transportation system provides access to daily needs and services for all users.
 - Objective 4.4: Reduce overall crash frequency and severity for all modes of travel.
 - Objective 4.5: Reduce transportation-related air emissions to improve air quality.



- Goal 5: Equity
 - Provide an equitable transportation system
- Objectives
 - Objective 5.1: Provide travel choices.

- 5.1.1 Provide travel choices for all residents and workers, regardless of race, age, ability, income level and geographic location.
- 5.1.2: Provide travel choices that allow residents and workers to adapt to changing economic conditions.
- Objective 5.2: Prioritize resources to address transportation needs of communities that have been historically underserved.
- Objective 5.3: Provide opportunities for residents of all races, ages and income levels to participate in project outreach activities and decision making.



- Goal 6: Fiscally Responsible
 - Maintain a fiscally responsible approach to protect and improve the existing transportation system and implement a cost-effective system to meet future needs.

Objectives

- Objective 6.1: Adequately repair and maintain existing transportation facilities and services.
- Objective 6.2: Prioritize projects that improve the existing transportation system for all modes of travel.
- Objective 6.3: Identify projects that improve operations and delay the need for more costly improvements.
- Objective 6.4: Identify and protect right-of-way for future transportation facilities and services.
- Objective 6.5: Support transportation projects that use public resources effectively and efficiently.
- Objective 6.6: Identify diverse, stable, long-term sources of funding.

- The Regulatory Review Memo is a common starting place for a major planning project.





Clackamas County TSP Compliance

- The Clackamas County TSP <u>must be</u> consistent with the TPR, OTP and OHP and Metro's RTP
- Current TSP (adopted in 2001) is <u>largely in</u> <u>compliance</u> with existing state and regional requirements but analysis and projects are out of date
- <u>However</u>, recent or proposed changes to regulations may require additional analysis as part of the TSP update



TSP Compliance with State Requirements

- Current TSP is generally in compliance with existing state requirements with the exception of the following areas of the TPR
 - Policies addressing higher density along transit systems, bicycle and pedestrian connections to transit
 - Out-of-date and/or vague policies for bus, passenger rail, transit oriented development, transportation disadvantaged, and transportation system management
 - Out-of-date project list
 - Funding and investment strategies

 Updated TSP will also need to be in compliance with new regulations in TPR and OHP, if they are adopted



Recent Changes in Regional Requirements -Inside Metro Boundary

- Metro Regional Transportation Plan (RTP) and Regional Transportation Functional Plan
 - Outcome-based planning focus
 - Performance targets
 - Emphasis on a well-connected arterial and local street network & bike/pedestrian connections to transit and essential destinations
 - Regional mobility corridors

- Title 6 of Metros' Urban Growth Management Functional Plan (UGMFP)
 - Incentives for regional investments and to allow higher v/c rations and a trip credit reduction
